#### MINIMUM QUALIFICATIONS

Applications will only be accepted from those who meet the following minimum qualifications:

Citizenship - Applicant must be a United States citizen.

**Age** - Applicants must reach their 21<sup>st</sup> birthday prior to completion of the Academy training, and must not be older than 39 on the first day of the Academy.

**Education** - Applicant must have a high school diploma or GED, and have attained a minimum of 60 semester credits from an accredited college. **Or**, must have 30 college credits along with either two years of active duty military service or two years as a full-time, Delaware-certified police officer.

(60 college credits are required in order to compete for the rank of Sergeant.)

(A Bachelor's Degree is required in order to compete for the ranks of Lieutenant and above.)

**Residence** – Applications are accepted from any U.S. citizen regardless of residency, however, at the conclusion of the academy training, Delaware residency is required.

**Driver's License** - Applicants must have a current valid driver's license and at least one (1) year driving experience. A DUI conviction within 2 years, or a suspension/revocation within 1 year, or an accumulation of ten (10) or more points at date of application is an automatic disqualification. A history of traffic violations may result in disqualification.

**Criminal Record and Activity** - Any felony conviction is an automatic disqualification. Any criminal activity that would be considered a felony under Delaware law, federal law, or the law of the state in which the activity occurred is a disqualification. **Applicants must have all prior criminal arrests expunged before being hired.** (Arrest or conviction for all other crimes and offenses are subject to evaluation).

**Drug Usage** – Any use of an illegal drug will be subject to review at the time the application is submitted, any prior use of a hallucinogenic drug, will be an automatic disqualification. All other drug use, including illegally using prescribed drugs, is subject to review.

**Weight** - Weight or body fat percentage must be in compliance with the attached Delaware State Police weight chart prior to receiving a final offer of employment.

\*Hearing - Normal hearing.

\*Vision – Visual acuity can be no worse than 20/40 in each eye (uncorrected) and must be corrected to 20/20 with glasses or gas permeable contacts; or, 20/100 in each eye (uncorrected) and must be corrected to 20/20 with soft contact lens **only**. Normal color vision and normal depth perception is required.

\*Following an offer of employment, the selected applicants will be examined by the Division's health providers for compliance with the above requirements, and will be given a complete medical examination to determine if the applicant is able to perform essential job functions.

#### PHYSICAL FITNESS ASSESSMENT

Each candidate is required to successfully complete a physical fitness assessment prior to being given consideration for employment.

The minimum requirements are located on the back of this page.

To participate in the physical fitness test, the attached PHYSICIAN AUTHORIZATION FORM must be completed and signed by your physician, and dated within one year.

Only those applicants who have been released by a certified medical physician to participate without risk to them will be permitted to perform. The purpose of the physical fitness assessment is to evaluate an individual's physical fitness. Each applicant's performance will be evaluated according to national fitness standards.

Applicants will be evaluated on the following:

#### **AEROBIC CAPACITY: 1.5 Mile Run**

Applicant is timed for 1.5 mile run on a running track or flat, measured surface. Applicants who display physical difficulties through the duration of the timed run will be removed from the exercise.

## STRENGTH: Push-ups (As many push-ups as possible in one minute)

<u>Males</u> — Hands placed shoulder width apart, elbows fully extended and back straight at all times. The applicant must reach full extension to complete one repetition. Pausing in the up position is permitted.

<u>Females</u> -- Will use the modified version with knees on the ground and feet in the air. Again, back must be kept in a straight line; arms fully extended and hands placed shoulder-width apart, slightly ahead of the shoulders. Applicant must come to full extension to complete one repetition. Pausing in the up position is permitted.

## **ENDURANCE:** Sit-ups (As many sit-ups as possible in one minute)

The applicant will begin by lying on his/her back with heels flat on the floor. He/she will bend knees and rise to a sit-up position with his/her hands cupped over or behind the ears. A partner may secure the applicant's feet. A sit-up will be executed by raising the upper body until it is perpendicular to the floor, and lowering the upper back down until the small of the applicant's back touches the floor. The applicant will do many sit-ups as he/she can in one minute.

The Delaware State Police Applicant Physical Fitness Test is a <u>PASS/FAIL</u> test. In the event that you do not pass any portion of the Physical Fitness Test, you will be disqualified at that time. However you may reapply for the next recruit class.
