

State Police Investigate Fatal Pedestrian Collision

Delaware State Police are investigating a fatal collision involving a pedestrian that occurred yesterday evening in the Milford area.

On December 4, 2022, at approximately 6:28 p.m., a silver 2008 Toyota Corolla was traveling southbound in the right lane on Bay Road approaching the intersection at Williamsburg Drive. At the same time, a pedestrian was walking eastbound across Bay Road's southbound lanes and into the path of the Toyota. The pedestrian was wearing dark clothing, not carrying a light, and not using a crosswalk. The driver of the Corolla attempted to brake and swerve to avoid striking the subject on foot but was unable to do so.

The pedestrian that was struck, a 49-year-old Milford man, sustained serious injuries. He was pronounced deceased at the scene and identification is pending notification to his family and relatives. The driver of the Corolla, an 18-year-old woman from Wilmington, Delaware, was not injured. The front-seat passenger, a 17-year-old male from Newark, Delaware, was transported to an area hospital for non-life-threatening injuries.

No other vehicles were involved in this collision. Bay Road was closed for approximately three hours while the scene was investigated and cleared.

State Police Investigating Fatal Collision on I-95

Delaware State Police are investigating a fatal vehicle collision that occurred yesterday evening in the Newark area.

On December 3, 2022, at approximately 10:17 p.m., a 2021 Hyundai Accent was stopped in the left center lane of Interstate 95 in the area of the Delaware House Travel Plaza /

Biden Welcome Center. At the same time, a 2020 International box truck was traveling southbound on I-95 in the same lane. The front of the box truck struck the rear of the Hyundai, and both vehicles continued forward until they collided with the guardrail on the right shoulder. Both vehicles went through the guardrail and came to rest off the west edge of southbound I-95.

The driver of the Accent, a 35-year-old man from Bear, Delaware, sustained serious injuries. He was transported to an area hospital for medical treatment but was sadly pronounced deceased later in the evening. Identification of the man is pending notification to his family and relatives. The driver of the box truck, a 50-year-old man from Fort Washington, Maryland, and the passenger, a 21-year-old man from Forth Washington, Maryland, were both transported to an area hospital for non-life-threatening injuries.

Southbound I-95 was closed for approximately five hours while the collision was being investigated and cleared. The Department of Natural Resources and Environmental Control (DNREC) hazmat team responded to the scene to address fuel that was leaking from the damaged Hyundai Accent.

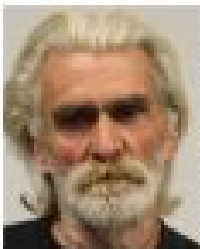

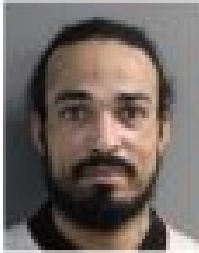

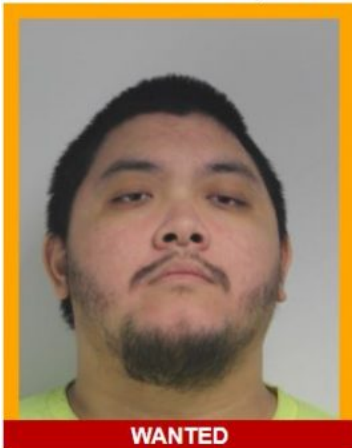

Dover Man Arrested for Attempted Burglary After Pursuit

Delaware State Police have arrested 44-year-old **Matthew Jester** of Dover, Delaware, for burglary, felony DUI, and numerous other charges following an investigation that began early this morning.

On December 2, 2022, at approximately 3:14 a.m., troopers responded to the 19000 block of Norwood Street in Rehoboth regarding a man who was attempting to burglarize a home. The man, later identified as Matthew Jester, had tried to force entry into a home and had threatened a resident with a large knife. Troopers arrived and attempted to contact Jester while he was seated in his pickup truck, but Jester fled the area in his vehicle and nearly struck a trooper who was standing

nearby. Jester continued northbound onto Coastal Highway at a high rate of speed and committed numerous traffic violations while troopers pursued him into the Milton area. The vehicle eventually stopped on Union Street Extension near Williams Farm Road after a Milton police officer successfully deployed a tire deflation device. Jester was removed from the vehicle and taken into custody after physically struggling with troopers on the roadside. A search of Jester's vehicle led to the discovery of a large fixed-blade knife and drug paraphernalia. Jester also showed signs of impairment.

Jester was transported to Troop 7 and charged with the following crimes:

- Possession of a Deadly Weapon During the Commission of a Felony (Felony)
- Attempted Burglary First Degree (Felony)
- 6th Offense DUI (Felony)
- Reckless Endangering First Degree (Felony)
- Aggravated Menacing (Felony)
- Criminal Solicitation Second Degree (Felony)
- Criminal Mischief Over \$5,000 (Felony)
- Resisting Arrest with Force or Violence (Felony)
- Disregarding a Police Officer Signal (Felony)
- Possession of Drug Paraphernalia
- Criminal Mischief Under \$1,000
- Disorderly Conduct
- Criminal Trespass Third Degree
- Numerous traffic offenses

Jester was arraigned by Justice of the Peace Court # 3 and committed to Sussex Correctional Institution on an \$81,700 cash bond.

Delaware State Police Investigate Multiagency Officer Involved Shooting

The Delaware State Police Homicide Unit are investigating a multiagency officer involved shooting in the Newark area this morning.

On December 2, 2022, at approximately 7:29 a.m., troopers were dispatched to the 100 block of Ayre St. outside of Newport in reference to a suspicious person with a gun. Upon contact, the subject fled on foot and was pursued by troopers. During the foot pursuit, the suspect pointed a gun at troopers and gunfire ensued. During this encounter, an occupied Vocational Technical School District bus was struck by gunfire at the corner of Marshall Street and Market Street. There were no injuries reported on the bus.

The suspect continued fleeing on foot to the area of Route 141 and Route 4 where he attempted at least one unsuccessful carjacking before carjacking a second victim and fleeing in that stolen vehicle. Troopers gave chase and there were additional gunshots fired at this location. The suspect was involved in a lengthy pursuit around both the New Castle and Newark areas until entering the cul-de-sac of Old Cooch's Bridge Road. At that location the suspect abandoned the vehicle and fled on foot through the wooded area towards southbound Interstate 95.

Once he reached the interstate, the suspect made two attempts to carjack unsuspecting victims. During the course of one attempt, the suspect discharged one round striking the interior of the vehicle. The suspect then successfully carjacked a third victim at this location. The pursuing officers were once again forced to engage the suspect and

ultimately fired at him. An uninvolved motorist was injured during this event. He was treated at an area hospital and released. The circumstances of this injury remain unclear and are under investigation at this time.

The suspect then continued to flee in the stolen vehicle on southbound I-95 until his vehicle came to a stop south of Route 896. Officers were forced to engage the armed suspect again and the suspect was shot. Troopers attempted to render first aid, but it was apparent that the suspect would not survive his injuries. Paramedics responded to the scene and the suspect was pronounced deceased.

The identity of the suspect is pending confirmation from the Medical Examiner's Office and notification to his family and relatives.

There were five agencies involved in this incident to include the Delaware State Police, New Castle County Police Department, Newport Police Department, Elsmere Police Department, and New Castle City Police Department.

Delaware State Police Investigating Collision Resulting in Four Fatalities

Delaware State Police are investigating a fatal motor vehicle collision that resulted in the deaths of four individuals in the New Castle area late last night.

On November 30, 2022, at approximately 11:30 p.m., a 2004 Ford F-150 was traveling southbound in the left northbound lane of Interstate 495 in the area of Route 13. At the time, a 2020 Toyota Tacoma was traveling northbound on Interstate 495 in the left lane. The Ford continued to travel southbound within the northbound lanes of Interstate 495 directly into the path of the Toyota resulting in a head on collision. Following the collision, both vehicles slightly rotated counterclockwise and came to rest a short distance from the point of impact.

The 48-year-old male operator of the Ford from Elkton, MD who was wearing his seatbelt, was pronounced deceased at the scene. Identification of the victim is pending notification to the next of kin.

The 41-year-old female operator of the Toyota from Philadelphia, PA, who was wearing her seatbelt, was pronounced deceased at the scene. Identification of the victim is pending notification to the next of kin. There were two occupants inside the Toyota, whose identities have not been confirmed at this time. They were both properly restrained and were pronounced deceased at an area hospital.

Interstate 495 northbound was closed between Interstate 95 and Route 13 for approximately five hours while the collision was investigated, and the roadway was cleared.

The Delaware State Police Troop 2 Collision Reconstruction Unit continues to investigate this incident.
