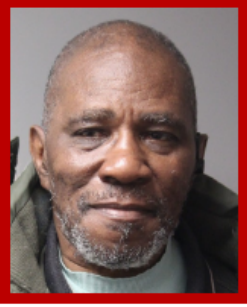

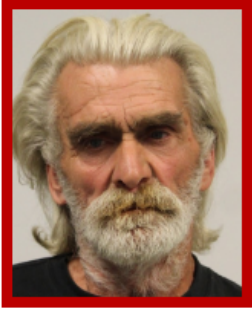

# Troopers Investigate Shooting Incident in Magnolia Community

**Magnolia, DE-** Delaware State Police are currently conducting a shooting incident that occurred early Thursday morning in a Magnolia community.

On March 3, 2022, at approximately 12:05 a.m., Delaware State Police responded to the 200 block of Jeffrey Drive, in the London Village Community, for a 30-year-old Magnolia man, with an apparent gunshot wound to his torso. He was transported to an area hospital by EMS, where he was pronounced deceased. Identification is pending notification to next of kin.

Delaware State Police Homicide Unit is currently in the early stages of this active investigation. The circumstances surrounding the incident remain under investigation. There is currently no suspect information.

Jeffrey Road was closed for approximately 6 hours as the on-scene investigation was conducted.

# Troopers Warn Public About Delaware State Police Phone Number Spoofing Scam

*Sussex County, DE-* The Delaware State Police are issuing the following advisory in response to a recent phone scam involving a “spoofed phone number”.

On February 28, 2022, Delaware State Police were made aware of two incidents in which individuals received a phone call from what appeared to be from Delaware State Police Troop 5. In one incident the victim was told they had to pay a fine on a sex offender charge and another was going to be arrested for jury duty fines.

As a reminder, the Delaware State Police will never request payment for fines, traffic tickets or bail. All these transactions are conducted by the respective court systems and never over the phone. Electronic payments are also never requested via phone for court matters.

Caller ID spoofing is when a caller deliberately falsifies the

information transmitted to your caller ID display to disguise their identity. Spoofing is often used as part of an attempt to trick someone into giving away valuable personal information so it can be used in fraudulent activity or sold illegally.

## **The following tips can help you avoid becoming victim to a spoofing scam:**

1. Don't answer calls from unknown numbers. If you do so by accident, hang up.
2. If a caller (live or recorded) suggests hitting a button to stop receiving calls from them, hang up. This can be a trick to engage you in conversation.
3. Never give out any [personally identifiable information](#) – for example, account numbers, Social Security Number, passwords or PINs, or your mother's maiden name.
4. If a caller claims to be with a legitimate company, call back using the phone number on a statement you have from them, or on their verified, secure website. This is particularly important if the caller asks you to verify personal information or make a payment.
5. If you are immediately pressured for information – be cautious. You are not obligated to answer any question asked of you.
6. Set your own password for your voicemail. Some voicemail services are set up to automatically allow access to your mailbox if you call in from your own phone. If a scammer spoofs your number, they can access your messages unless there is a password or PIN requirement in place.
7. Use a call blocking tool (talk to your phone company) or reputable app on your mobile device. There are different options for different platforms. Do some research and choose the one that makes the most sense for you.

# Troopers Arrest New York Man for Felony Assault

*Newark, DE-* Troopers arrested **Pernell Louissol, 31, of Brooklyn, NY,** for felony assault after stabbing a coworker during a physical altercation.

On February 26, 2022, at approximately 10:27 p.m., troopers responded to a stabbing that reportedly occurred in the area of northbound I-95 and exit ramp for DE 7. Upon arrival, troopers located a Ford passenger van with several people standing outside on the shoulder of the roadway. Troopers located an 18-year-old male with a laceration to his left arm, causing severe bleeding. Troopers provided care to stop the bleeding, and EMS transported the victim to a nearby hospital with a non-life-threatening injury.

The investigation determined the victim and Pernell Louissol were traveling with coworkers in the van when an argument ensued between the two men. The victim, who was driving, pulled over, and the two exited the van and began fighting on the shoulder of I-95. Coworkers broke up the altercation, and they all got back into the van. Prior to the victim driving off, the two men began arguing, which again turned into a physical altercation. During the fight, the victim discovered he was bleeding from his arm and passed out.

Pernell was taken into custody without incident and transported to Delaware State Police Troop 2, where he was charged with Assault Second Degree (Felony). He was arraigned in the Justice of the Peace Court #11 and committed to Howard R. Young Correctional Institution on a \$5,000.00 cash bond.

## **\*UPDATE\* Troopers Investigate Fatal Collision North of Harrington**

*Harrington, DE-* Delaware State Police are investigating a

fatal two-car collision that occurred Saturday night north of Harrington.

On February 26, 2022, at approximately 6:53 p.m., a 31-year-old Marydel, MD, man was driving a Honda Civic northbound on S. DuPont Hwy (US 13) in the left lane approaching the intersection of Hopkins Cemetery Rd. The Civic entered the left turn lane and median crossover and then, without stopping, began crossing southbound S. DuPont Hwy to Hopkins Cemetery Rd. At the same time, a 31-year-old Salisbury, MD woman was driving a GMC Terrain southbound on S. DuPont Hwy (US 13) in the right lane approaching the intersection of Hopkins Cemetery Rd. As the Honda crossed into the path of the GMC, the front bumper of the GMC struck the Honda's passenger side door within the right lane of S. DuPont Hwy. After the collision, the GMC pushed the Honda into a stop sign and then into the parking lot of Callaway Furniture located at 15152 S. DuPont Hwy.

The 31-year-old Marydel, MD man, was flown to an area hospital where he was admitted in serious condition. Seated in the front passenger seat of the Honda was a 30-year-old Bridgeville man who sustained fatal injuries and was pronounced dead at the scene. Identification is pending notification to next of kin.

EMS transported the 31-year-old Salisbury, MD woman to an area hospital where she was admitted for non-life-threatening injuries. Also in the GMC was a 59-year-old female, a 31-year-old female, a 6-year-old female, a 5-year-old female, and a 3-year-old male. All passengers were transported to an area hospital, where they were treated for minor injuries and released.

# **Delaware State Police Investigate Fatal Pedestrian Crash West of New Castle**

**New Castle, DE**– Delaware State Police are investigating a fatal pedestrian collision that occurred Friday night west of New Castle.

On February 25, 2022, at approximately 7:29 p.m., a **65-year-old Bear man** was traveling northbound on Bear Christiana Road (DE SR 7) approaching Newtown Road. Just prior to Newtown Road, a truck the Bear man was following had a couch fall out of the back into the roadway, landing partially in the center

median and partially in the left travel lane of southbound DE SR 7. The victim and another driver stopped in the left turn lane of DE SR 7 northbound, south of Newtown Road, to remove the couch from the roadway. As the Bear man entered the left travel lane of southbound DE SR 7 to help remove the couch from the road, a 2008 Dodge Dakota was traveling southbound on DE SR 7 in the left travel lane approaching the intersection with Newtown Road. As the Dodge traveled through the intersection, the pedestrian was still in the left travel lane. The driver of the Dodge saw the pedestrian at the last second and veered to the right, attempting to avoid the collision. Unfortunately, the driver was unsuccessful, and the left front of the Dodge struck the victim within the left travel lane of southbound DE SR 7. The other individual helping to move the couch was uninjured.

The 65-year-old Bear man was transported to a nearby hospital by EMS, where he was pronounced deceased. Identification is pending notification to next of kin.

The 42-year-old Middletown man driving the Dodge Dakota was not injured.

The collision's location is dark and only slightly illuminated by nearby lighting. Both directions of DE SR 7 were closed to vehicular traffic between Newtown Road and Freedom Road for approximately 3 hours while the crash was investigated and cleared.
