

Troopers Attempt To Identify Aggravated Menacing Suspect – Middletown

Middletown– The Delaware State Police are attempting to identify the suspect (pictured above) involved in an Aggravated Menacing incident that occurred Wednesday afternoon.

On March 17, 2021, at approximately 1:47 p.m., an unknown suspect operating a gray Ford Escape followed a 30-year-old male victim of Wilmington, in an apparent road rage incident. The victim pulled his vehicle into a parking lot located off of Marl Pit Road at which time the suspect pulled up next to the victim and displayed a black handgun towards him. The suspect verbally threatened the victim, then fled eastbound toward Route 13.

The suspect is described as a white male approximately 50-60 years old.

Troopers Investigating Carjacking – Claymont

Claymont – The Delaware State Police are investigating a carjacking that took place at the intersection of Philadelphia Pike and Harvey Road early this morning.

The incident occurred at approximately 1:00 a.m., Monday, March 15, 2021, when a 20-year-old victim operating a blue Ford Fiesta was stopped in the left turn lane of northbound Philadelphia Pike at Harvey Road. The victim was approached by an unknown suspect who displayed a handgun and demanded her out of the vehicle. The victim complied and the suspect fled the scene in the stolen vehicle. 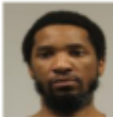

Delaware State Police Warn Residents of Recent Scam Trend- Delaware

Delaware– Delaware State Police are issuing the following advisory in response to a recent phone scam reported in Delaware.

The Delaware State Police have recently taken reports of incidents where individuals have received phone calls from someone posing as a family member in trouble and need financial assistance. During these most recent scam calls, the recipient is instructed to withdraw a large amount of money, and a courier responded to the residence and collected the money. As a reminder, if someone calls and advises a family member is in trouble and needs money sent to them, immediately attempt to contact the family member to verify their status on your own. Never assume because the person calling knows the family members' name that the request for money is valid.

Indicators of scam calls are threats, orders to not hang up, and other statements about immediacy.

To help prevent these types of calls, talk to your phone company about call blocking tools they may have, and check into apps that you can download to your mobile device to block unwanted calls.
