

Delaware State Police Investigating Fatal Motor Vehicle Collision- Wilmington

Wilmington – Delaware State Police are investigating a fatal motor vehicle collision that was discovered Thursday afternoon.

On February 25, 2021, at approximately 2:17 p.m., DELDOT personnel were working on I-495 in the area of Edgemoor Road when they noticed damage to a section of guardrail on the right side of northbound I-495. After further inspection, the DELDOT personnel discovered a 2009 Ford F-150 approximately 200-300 feet off the roadway and down a steep embankment in the area of the damaged guardrail and they contacted the Delaware State Police.

The investigation determined on February 17, 2021, at approximately 11:53 p.m., the Ford was traveling northbound on I-495 in the area of Edgemoor Road. For unknown reasons, the vehicle veered off the roadway and the front collided with the guardrail. After impact, the Ford traveled down a steep embankment and overturned multiple times before coming to rest in an area of overgrown brush. The 65-year-old male operator of Chester, PA, was located in the vehicle at the time of the investigation and was pronounced deceased at the scene. Identification of the victim is pending notification to next of kin.

Troopers Investigating Fatal

Crash Involving an Off-Highway Vehicle- Dover

Dover- Delaware State Police are conducting a fatal crash involving an off-highway vehicle that occurred Wednesday night.

On February 24, 2021, at approximately 9:08 p.m., a Honda CRF-450 Dirt Bike operated by a 33-year-old male of Dover, was traveling northbound on Peachtree Run approaching the intersection of Vanessa Drive. A silver 2011 Hyundai Sonata operated by a 21-year-old male of Dover was traveling southbound on Peachtree Run, approaching Vanessa Drive and preparing to make a left turn onto Vanessa Drive. The Hyundai proceeded to make the left turn onto Vanessa Drive and the right quarter panel was struck by the front of the dirt bike.

The Honda CRF-450 Dirt Bike is an off-highway vehicle, and is not street legal. It was not equipped with any lighting source (headlights, taillights, or reflective material).

The Hyundai came to stop shortly after the collision at the entrance to Vanessa Drive and remained on scene. The operator was not injured during the collision.

The operator of the Honda was transported to a nearby hospital where he succumbed to his injuries. Identification of victim is pending notification to next of kin.

Delaware State Police Investigating Fatal Motor Vehicle Collision- Felton

Felton— Delaware State Police is investigating a single fatal motor vehicle collision that occurred late Tuesday night.

On February 23, 2021, at approximately 11:00 p.m., a 2003 Honda Accord was traveling southbound on Canterbury Road south of Roesville Road, approaching the Coursey Pond boat ramp. The **29-year-old male** operator of Ellendale failed to negotiate the curve in the roadway and lost control of the vehicle. The Honda crossed over the northbound lane and shoulder, exited the east edge of the road, and drove in an uncontrolled manner through a grassy embankment and over several driveway entrances. The vehicle steered back towards Canterbury Road before it began to roll several times and came to rest on Canterbury Road on its roof.

The 29-year-old male operator was pronounced deceased at the scene. Identification is pending notification to next of kin.

Canterbury Road was closed for approximately 4 hours while the investigation was completed, and the roadway was cleared.

Magnolia- Delaware State Police identified the individual who was killed during an altercation on February 6, 2021, at approximately 3:25 a.m., on Millchop Lane, Magnolia, as 37-year-old **Sergio Wilkerson** of Smyrna.

Delaware State Police arrested 46-year-old **James Palmer** of Dover for the murder of Wilkerson and charged him with the following crimes:

- Murder 1st Degree (Felony)
- Attempted to Commit Murder 1st Degree (Felony)
- Possession of a Deadly Weapon During the Commission of a Felony (Felony)- 2 counts

Palmer was arraigned in the Justice of the Peace Court #11 and committed to the Howard R. Young Correctional Institution on a \$1,120,000 cash bond.

Traffic Stop Leads to Arrest of Bear Man for Felony Drug and Weapon Charges- Bear

Bear— Delaware State Police arrest 27-year-old **Jahmere Irvin** of Bear on felony drug and weapon charges following a traffic stop on Saturday night.

On February 20, 2021, at approximately 9:35 p.m., Delaware State Police conducted a traffic stop on a red Subaru sedan in the area of Pulaski Highway and School Bell Road for a registration violation. As contact was made with the occupants, a strong odor of marijuana was detected inside the vehicle. Troopers contacted the 24-year-old male operator of Wilmington and front-seat passenger, later identified as Jahmere Irvin. A criminal investigation ensued. When the driver was questioned if there was any marijuana inside the vehicle, Irvin produced a plastic bag with approximately 59.98 grams of marijuana to the trooper. Irvin was removed from the vehicle, and located on his person was a Jimenez Arms Inc 9mm handgun with a magazine containing nine live 9mm rounds with one in the weapon's chamber. Also, on his person was approximately 31.16 grams of marijuana.

A probable cause search was conducted on the Subaru, and the following was located inside:

- Approximately 1,089.56 grams of marijuana
- Drug Paraphernalia
- 11- 9mm Lugar live ammo rounds

Irvin was taken into custody without incident and charged with the following crimes:

- Possession of a Firearm During the Commission of a Felony (Felony)

- Possession With Intent to Deliver a Controlled Substance (Felony)
- Carrying a Concealed Deadly Weapon (Felony)
- Possession of a Deadly Weapon by a Person Prohibited (Felony)
- Possession of Drug Paraphernalia

He was arraigned in the Justice of the Peace Court #11 and committed to Howard R. Young Correctional Institution on a \$31,500.00 cash bond.

Delaware State Police Investigating a Fatal Single Motor Vehicle Collision- Magnolia

Magnolia– Delaware State Police are investigating a fatal motor vehicle collision that claimed the life of a 39-year-old Felton woman.

On February 20, 2021, at approximately 10:44 p.m., a 2019 Acura MDX operated by a 37-year-old male of Felton was traveling southbound on McGinnis Pond Road approaching a sharp right bend in the roadway, north of Lexington Mill Road. The operator failed to negotiate the curve and exited the travel lane, crossing into the northbound lane, and exited the east edge of the roadway before traveling through a private yard and striking a tree with its front bumper.

After striking the tree, the vehicle rotated in a clockwise manner before coming to rest and catching fire. The operator exited the Acura on his own, but the front seat passenger had to be removed by nearby responding citizens. Neither appeared to have suffered injuries from the fire.

The 37-year-old male operator was transported to a nearby hospital by ambulance with non-life-threatening injuries.

The 39-year-old female front seat passenger was not wearing a seatbelt and was pronounced deceased at the scene. Identification is pending notification to next of kin.

The roadway was closed for approximately 3.5 hours while the investigation was completed, and the roadway was cleared.
