The Professional Licensing Section oversees the following industries: 1) Private Investigator & Private Security Agencies (PI & PSA) – security guards, firearms guards, private investigators, armored card guards, and their respective agencies; 2) Security Alarm Systems & Protective Services Agencies (SAS & PSA) – alarm employees and their agencies; 3) Pawnbrokers, Secondhand Dealers, & Scrap Metal Processors (PBSS); 4) Constables – entities and individuals; 5) Bail Enforcement Agents (BEA) – NOT Bail Bondsmen; 6) Retired DSP – HR 218 & CCDW Permits.
